- Sa chás go bhfaightear cealú tar éis túis an téarma, ní bheidh aon aisíoc ar an táille téarma ar fáil.

Déanfar iarratais ar aisíoc a thagann lasmuigh de na rialacha thusa a mheas i gcúinsí eisceachtúla amháin.

## 2 Full Year Residential Courses

Term fees are due prior to the commencement of each term.

### Refunds

- Where a cancellation is received no later than 20 working days after the relevant acceptance date, 75% of the deposit may be refunded;
- Where a cancellation is received later than 20 working days after the relevant acceptance date, no refund of the deposit will be available;
- Where a cancellation is received after the beginning of a term, no refund of the term fee will be available.

Requests for a refund that fall outside of the above rules will be considered only under exceptional circumstances.

#### Refunds

- Where a cancellation of a place on a course is received no later than 40 working days prior to the start of the course, Coláiste na Rinne is happy to refund the full course fee including deposits, less a €100 administration fee;
- Where a cancellation is received no later than 30 working days prior to the start date of the course, the full course fee less the deposit may be refunded;
- Where a cancellation is received no later than 5 working days prior to the start date of the course 50% of the course fee, less the deposit, may be refunded;
- Where a cancellation is received later than 5 working days prior to the start date of the course no refunds will be available.

Requests for a refund that fall outside of the above rules will be considered only under exceptional circumstances.

## 4 Other Courses

The balance of course fees are due no later than 20 working days prior to the commencement of the course.

### Refunds

- Where a cancellation of a place on a course is received no later than 40 working days prior to the start of the course, Coláiste na Rinne is happy to refund the full course fee including deposits where relevant.
- Where a cancellation is received no later than 20 working days prior to the start date of the course the full course fee less the deposit, or where no deposit is applicable less a €50 administration fee, may be refunded;
- Where a cancellation is received no later than 5 working days prior to the start date of the course 50% of the course fee, less the deposit where relevant, may be refunded;
- Where a cancellation is received later than 5 working days prior to the start date of the course no refunds will be available.

Requests for a refund that fall outside of the above rules will be considered only under exceptional circumstances.

## 5 Liosta Feithimh

Nuair a bhíonn cursa lán, is féidir áit a fháil ar an liosta feithimh don gcúrsa sin ach an éarlais a íoc.

### Aisíoc

- Aisíocfar an éarlais d'áit ar liosta feithimh ina iomláine sa chás nach mbíonn áit ar fáil ar an gcúrsa;
- Roimh d'áit ar an gcúrsa a bheith ar fáil, tá cead ag iarrthoir tarrant siar ón liosta feithimh ag aon am, agus aisíocfar an éarlais ina iomláine;
- Sa chás go dtagann áit ar an gcúrsa ar fáil, agus ní ghlacfar leis an áit, aisíocfar an éarlais ina iomláine.

## 6 Athbhreithniú ar an bPolasaí

Athbhreithneoidh Coiste Bainistíochta an Choláiste an polasaí seo gach tríú bliain, nó comh luath agus is féidir i ndiaidh rialúcháin nó dlí nua a bhíonn tionchar aige ar an bpolasaí seo.

## 5 Waiting List

Where a course is full, a place on the course waiting list can be secured by paying the deposit for the course.

### Refunds

- A waiting list deposit will be refunded in full where a place on the course does not become available.
- Prior to a place on the course becoming available, the applicant may withdraw from the waiting list at any time and the deposit will be refunded in full.
- Where a place on the course becomes available but is not taken up, the deposit will be refunded in full.

## 6 Policy Review

This policy will be reviewed every third year by Coiste Bainistíochta an Choláiste, or as soon as practicable following a new law or regulation which impacts on this policy.
